**3YO & PRE-PREP KINDERGARTEN SESSION TIMES:**

Eligible children have access to kindergarten for up to 15hr per week\*. This program attracts both the CCS and kindergarten subsidy. A combination of long and short days can be used to achieve this. Wrap around care can be used for your child's kinder days where you require additional care out of kindergarten hours at an additional cost. Kindergarten sessions only run during term dates. Long day care rates apply during school holidays for children accessing care during their normal kindergarten sessions.
